



ORANGE LUTHERAN EVENT WAIVER: MINOR

Media Release: I authorize Orange Lutheran High School, at its sole discretion, to use and publish for any lawful purpose and without compensation, photographs, video, audio and/or other depictions of my child at this event. This authorization shall remain in effect until revoked in writing.

Liability Release: I hereby assume risk of, responsibility and liability for, and release, forever discharge and agree to hold harmless Orange Lutheran High School, its employees, officers, agent, volunteers and event participants, from all liability, claims, demands, expenses, costs and obligations directly or indirectly resulting from personal injury, sickness, death and/or property damage associated with any activity covered by this form. I further agree to hold harmless, defend and indemnify Orange Lutheran High school, its employees, officers, agent, volunteers and event participants for all liability, claims, demands, expenses, costs and obligations directly or indirectly caused by the negligent, willful or intentional act of my child, including expenses incurred attendant thereto. I understand and acknowledge that these activities, by their very nature, pose the potential risk of serious injury/illness to individuals who participate in such activities. I understand and acknowledge that participation in these activities is completely voluntary.

Medical Release: I authorize an adult sponsor of Orange Lutheran High School, Orange, CA, to consent to any X-ray, examination, anesthetic, medical or surgical supervision and on the advice of any physician or surgeon licensed to practice in the state of treatment, when the need for such treatment is immediate, and when efforts to contact me are unsuccessful. This authorization given pursuant to Section 25.8 of the Civil Code of California.

Covid Release of Liability and Policy Acknowledgement: I agree to my child and/or guardian completing a questionnaire related to COVID-19 symptoms. I certify that if my child is experiencing any of the following symptoms, that they will not attend camp or the workshop:

- a. A fever of 99 degrees or higher within 72 hours of the event;
- b. Shortness of breath within 48 hours;
- c. Cough within 48 hours;
- d. Chills, or repeated shaking with chills, within 48 hours;
- e. Loss of taste or smell within 48 hours; and/or
- f. Close contact (i.e., stood within 6 feet) with an individual diagnosed with COVID-19, an individual in quarantine in connection with COVID-19; or an individual exhibiting flu-like symptoms within the past 14 calendar days.

I agree to my child having their temperature taken upon their arrival to a camp or workshop.

Anyone who refuses to agree to have their temperature screened or has a temperature of over 100.4 will be denied access to attending the camp/workshop.

I agree that my child will need to stay socially distant and need to wear a mask if they will be within 6 feet of another person, per the current COVID-19 Face Mask Policy. I understand that I must inform the Program's leaders immediately if my child is diagnosed with COVID-19, and they must not attend going forward. I agree to comply with any and all disinfecting and hygiene protocols developed by Orange Lutheran High School including but not limited to hand washing or hand sanitizer, I understand the risks inherent to the potential contraction of COVID-19. I further agree to release Orange Lutheran High School, its employees, officers, agent, volunteers and event participants, of any and all liability in the event that I am exposed and/or become infected with COVID-19 and waive my right to file any claims against Orange Lutheran High School related to any actual or potential exposure to COVID-19.
